Before Fraxion

Mobile app

Fraxion's mobile app has become an indispensable tool for Mukuru's Heads of Departments (HODs), particularly in dynamic fields like marketing and sales where frequent travel is standard practice. The mobile app offers a level of convenience that resonates with these on-the-go decision-makers. HODs express a strong preference for managing approvals directly on their mobile devices, citing the comfort and flexibility it provides, with no requirement to use the proxy functionalities that exist.

Sales agents, often engaging with customers in the field, have also embraced Fraxion's mobile app for expense claims. The user-friendly interface facilitates timely submission of claims, aligning with the fast-paced nature of their work. Invoices
